Explanatory Note

This Amendment No. 2 to Schedule 13D ("Amendment No. 2") amends and supplements the Schedule 13D originally filed with the United States Securities and Exchange Commission on October 4, 2021 (as amended to date, the "Schedule 13D"), relating to the shares of voting common stock, par value \$0.0001 per share (the "Common Stock"), of Jasper Therapeutics, Inc., a Delaware corporation (the "Issuer").
